### INTRODUCTION

EDARA's international cooperation has remained robust and far-reaching, extending across the European Union, Africa, Central Asia, the Caucasus, and Latin America. The centre has organised, co-sponsored, and participated in a wide range of international events including conferences, expert workshops, and high-level consultations and has produced analytical reports addressing key aspects of global security, encompassing intellectual, energy, and social dimensions, as well as climate change and the proliferation of extremist narratives. In 2025, special attention was dedicated to analysing the repercussions of ongoing global conflicts, notably the Russia–Ukraine war and the protracted confrontations in Gaza and Lebanon, both of which have resulted in severe humanitarian crises, profound regional instability, and an alarming acceleration of global polarisation.

This year, EDARA has made substantial scholarly contributions through the publication of multiple reports and peer-reviewed articles addressing key issues of terrorism, violent extremism, and governance in both national and international contexts. In addition, EDARA has produced specialised analytical studies on climate change, energy security, and contemporary Islamism, and has actively participated in a range of European Union and international events of strategic significance. These activities, spanning Europe, the MENA region, Africa, Central Asia, and the Caucasus, have reinforced EDARA's identity as a strategic European research institution positioned at the intersection of academic inquiry and policy engagement. Looking ahead, EDARA aims to further consolidate its institutional standing by strengthening its programmes, partnerships, and research collaborations. The centre's principal objective remains twofold: to advance a global culture of peace as both an analytical framework and a concrete practice, and to operationalise this vision through continuous field engagement and scholarly cooperation. EDARA will also continue its multilingual publication strategy in English, French, Dutch, and Arabic thereby broadening its intellectual scope and reaching diverse audiences throughout Europe and beyond.

### INTRODUCTION

The year 2026 will mark the fourteenth anniversary of EDARA's foundation a milestone that offers an occasion to reflect on the centre's evolution, assess the geopolitical and social transformations of recent years, and define new strategic directions for the future.

A defining highlight of 2025 was the landmark initiative "2025 – The Year of the Islamic World in Belgium and Europe." Conceived as an innovative platform for intercultural dialogue and mutual understanding, this initiative sought to strengthen the relations between Europe and the Islamic world in a period marked by deep geopolitical uncertainty and intensifying global polarisation.

Organised in partnership with ICESCO, the Baku International Multiculturalism Centre (BIMC), and the Caucasus Muslim Board (CMB), the initiative included a series of high-level events held on 6–7 March 2025 in Brussels. These events comprised:

A High-Level Roundtable at the European Parliament

A European Conference on Models of Multiculturalism

The Celebration of International Women's Day at the UN Women House in Brussels, entitled "Women's Empowerment: Challenges and Opportunities"

A Gala Iftar Dinner, attended by more than one hundred distinguished guests, including fifteen ambassadors, representatives of the European Parliament and the European External Action Service (EEAS), as well as prominent academics from various European and international institutions. The initiative pursued several interrelated objectives:

To establish a secure and inclusive platform for exchange between the Islamic world, Belgium, and the European Union, thereby fostering mutual understanding and lasting bonds of cooperation.

To engage in substantive dialogue with European policymakers and institutions on issues of shared global concern.

To promote models of peaceful coexistence and intercultural dialogue, moving beyond frameworks centred exclusively on securitisation.

To strengthen cooperation in research, education, peacebuilding, and socio-economic development in collaboration with BIMC, CMB, and ICESCO.

To explore new and sustainable avenues for international collaboration between institutions in the Muslim world and their European counterparts.

The initiative, "2025 – The Year of the Islamic World in Belgium and Europe," represents a landmark achievement in EDARA's enduring commitment to fostering dialogue among civilisations, advancing intercultural understanding, and building durable pathways to peace and cooperation through knowledge, diplomacy, and collaborative engagement.



# THE INITIATIVE, "2025 - THE YEAR OF THE ISLAMIC WORLD IN BELGIUM AND EUROPE

The "Year of the Islamic World in Belgium and Europe" was conceived as an ambitious framework for dialogue, cooperation, and intercultural engagement. Its core objective was to create a secure and inclusive platform for exchange between the Islamic world, Belgium, and the European Union, fostering mutual understanding and durable bonds of partnership. The initiative aimed to promote substantive dialogue with European policymakers and institutions on issues of shared global concern, while advancing models of peaceful coexistence and intercultural dialogue that move beyond narratives centred solely on securitisation. It also sought to strengthen collaboration in research, education, peacebuilding, and socio-economic development through close partnerships with BIMC, CMB, and ICESCO. Furthermore, it aspired to open new and sustainable avenues for international cooperation between institutions in the Muslim world and their European counterparts, reinforcing a shared commitment to peace, development, and mutual respect.

Multiculturalism emerges not as a mere normative aspiration but as an indispensable policy paradigm, enabling constructive intercultural exchange amid persistent tensions of identity, belonging, and social cohesion. This approach reorients diversity from a site of potential fragmentation toward a generative resource, cultivating inclusive civic practices and resilient models of coexistence grounded in reflexive recognition of difference and shared humanistic commitments.




## The Arbitration of Empire: Colonial-Era Disputes and Emerging Risks to European Courts.

The report addresses a significant gap in existing legal and policy literature. Although there is growing scrutiny of international arbitration and litigation finance in isolation, no study has yet traced how historical grievances risk converging with speculative enforcement strategies. This analysis is the first to frame that convergence as a post-imperial risk ecosystem one shaped not only by the reactivation of colonial-era instruments but by their interaction with litigation funders, fragmented enforcement regimes, and gaps in European regulatory frameworks.

European courts, the report argues, are central to this risk. Their openness to enforcement under the New York Convention, coupled with a lack of harmonised rules for evaluating legacy claims or scrutinising TPLF, makes them prime targets for funder-led litigation. The Malaysia-Sulu case has already demonstrated the potential for forum shopping and arbitrator overreach; future cases could replicate these tactics, even without a strong legal foundation, so long as the commercial incentives are aligned.

#### Reading the US National Security Strategy with Strategic Maturity



The report addresses the new United States National Security Strategy (NSS) has triggered strong reactions across Europe. It portrays Europe as demographically fragile, overregulated, weakened by migration and "civilisational" drift, and calls on Europeans to assume more responsibility for their own security while the US reprioritises its own hemisphere. This is abrasive, and in places inaccurate. But for serious European policymakers, the NSS should be read first of all as a clarified US baseline: a condensed selfportrait of how Washington currently understands its interests, priorities and limits.


## Fostering Confidence and Dialogue: The Utrecht (Overvecht) Trust Building Project 2026
